What designation means

- Properties designated "as is"
 - No required improvements

Design Review

- Goal to preserve historic character of the property
- All exterior alterations require Landmark review
- Demolition highly discouraged
 - Requires Commission review
- Eligible for Historic Preservation Tax Credits



Who Can Apply for Designation?

- Community-driven process
 - Owner(s) of the property
 - Manager of Community Planning and Development
 - Member(s) of City Council
 - Three residents of Denver





Landmark Designation Eligibility

The structure or district must meet the following criteria *:

- 1. Maintains its integrity
- 2. More than 30 years old, or is of exceptional importance
- 3. Meets at least three of ten criteria
- 4. The LPC considers the historic context

*Per Landmark Preservation Ordinance (Chapter 30, DRMC)

Designation Criteria: Meet 4 out of 10

- A. Historic development of city
- **B. Recognized persons who had influence on society**
- **C.** Visible characteristics of architectural style or type
- Architecture D. Significant example of recognized architect or master builder
 - E. Significant innovation or technical achievement
 - Geography

History

- F. Familiar feature of neighborhood, due to physical character
- G. Understanding of urban environment through physical characteristics or rarity
- H. Cultural understanding of how the site was used by past generations
- **Culture** I. Physical attribute that is source of pride or cultural understanding
 - J. Social movements, institutions, or patterns of growth that contributed to culture

MOMA Exhibit, 1932: International Exhibition of Modern Architecture

- Regularity and balance without symmetry
- No applied ornament
- Volume over mass with thin surface materials giving buildings a lighter appearance






International Style

- Avant-garde and architect-designed
- Modern architecture introduced by architects emigrating to escape chaos in Europe
- Brought experience with architecture designed to exploit modern materials and technology
- Emphasized building functionalism and the elimination of any features that were just decorative
- Most domestic examples from 1930s in Northeast or California

International Style *Residential*

- Minimal decoration
- Flat roof
- Smooth wall surfaces
- Asymmetrical
- Long ribbons of windows
- Plate glass windows set flush with wall
- Large blank expanses of exterior walls



C. Embodies the distinctive visible characteristics of an architectural style or type

- Excellent example of an Internationalstyle residence in Denver
- Character-defining features of 2323 E. Dakota Ave.
 - Horizontality
 - Asymmetry
 - Ribbon windows
 - Cubist conception of building volumes
 - Lack of ornamentation
 - Flat roof

D. Significant example of the work of a recognized architect or master builder

- Casper Forman Hegner
 - Born 1909 in Ohio, moved to Denver in 1913
 - Degrees from Princeton and Yale
 - In 1931 he traveled to Europe and studied at the summer program of the American School of Fine Arts (Fontainebleau, France)





D. Significant example of the work of a recognized architect or master builder

- Casper Forman Hegner
 - Moved to Denver in 1935
 - 2323 E. Dakota Ave earliest Denver work and the most intact example of his early International-style dwellings
 - After WWII, established Smith,
 Hegner, and Moore and, later, Smith and Hegner





Landmark Designation Review Criteria

- Over 30 years of age
- Application meets at least three criteria
- Retains Integrity
- LPC considered the historic context
- City Council considers
 - Recommendation of LPC
 - Written views of owners
 - Comments received at public hearing

Based on the ordinance designation criteria and on the findings of the Landmark Preservation Commission (LPC) that the application meets the criteria for designation of a structure, staff recommends approval of the application.
