AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and CARAHSOFT TECHNOLOGY CORPORATION, a Maryland corporation, whose address is 11493 Sunset Hills Road, Suite 100, Reston, VA 20190 (the "Contractor"), individually a "Party" and collectively the "Parties."

WHEREAS, the Parties entered into an Agreement dated December 13, 2022, for various cloud computing solutions (the "Agreement"); and

WHEREAS, the Parties now wish to modify the Agreement as set forth below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties incorporate the recitals set forth above and amend the Agreement as follows:

- **1.** Subsection 4.4.1 of the Agreement, titled "<u>Maximum Contract Amount</u>," is amended to read as follows:
 - **"4.4.1.** Notwithstanding any other provision of the Agreement, the City's maximum payment obligation will not exceed Forty-One Million Eight Hundred Eleven Thousand Four Hundred Seventy-Six Dollars (\$41,811,476.00) (the "Maximum Contract Amount"). The City is not obligated to execute an agreement or any amendments for any further services, including any services performed by the Contractor beyond that specifically described in **Exhibits A** and **B**. Any services performed beyond those in **Exhibits A** and **B** or performed outside the Term are performed at the Contractor's risk and without authorization under the Agreement."
 - 2. Except as amended here, the Agreement is affirmed and ratified in each and every particular.
- **3.** This Amendatory Agreement is not effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
