A RESOLUTION

Laying out, opening and establishing as part of the City street system a parcel of land as South Colorado Boulevard, located at the intersection of South Colorado Boulevard and East Ellsworth Avenue.

BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Executive Director of the Department of Transportation and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described portion of real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:
