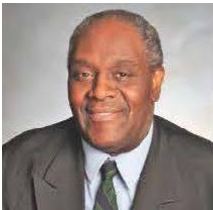
**CURRENT BOARD STATUS**

**Scope of Board/Commission:** THE AUTHORITY IS RESPONSIBLE FOR DEVELOPING, MANAGING AND MAINTAINING LOW RENT HOUSING PROJECTS FOR FAMILIES OF LOW AND MODERATE INCOME. ALSO RESPONSIBLE FOR HIRING THE EXECUTIVE DIRECTOR.

**Appointment Process:** Mayor appoints all members and City Council confirms, 9 members for a term of 5 years.

**Reappointment Candidate:**

**Craig Allen** (Male)(African American)



**BIO:** Mr. Allen sits in the seat for the resident commissioner who is directly assisted as a public housing resident or a recipient of housing assistance in the tenant based section 8 program. He qualifies as directly assisted under both sections. Mr. Allen has proven to be a valuable member of the DHA Board of Commissioners. He has built his capacity and understanding of the organization over the last five years.

**Term:** 07/20/2024 - 07/19/2029 or until a successor is duly appointed.
