6 **For an ordinance amending Ordinance No. 458, Series of 2024 to change the**  
7 **Fund associated with the Climate Action and Sustainability Capital**

10 **WHEREAS**, Ordinance No. 458 Series of 2024 approved a rescission from and an  
11 appropriation in the Climate Protection Fund to make a cash transfer to the Climate Protection  
12 Capital Projects Fund to support the Solar Infrastructure Improvements Capital Programs; and

13 **WHEREAS**, Section 3 of the ordinance made the appropriation in the wrong Fund; and

14 **WHEREAS**, this is an administrative action to correct the capital fund number;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**

19 **Section 1.** That Section 3 of Ordinance 458, Series of 2024, is hereby amended to read as

22 **“Section 3.** From the Capital Improvements and Capital Maintenance Fund  
23 Series, Accounting No. 31000, out of monies transferred in section 2 and in  
24 addition to amounts heretofore appropriated by Ordinance No. 1682, Series of  
25 2023, and any supplemental appropriations or rescissions, there is hereby  
26 appropriated to the appropriation accounts hereinafter designated the amount of  
27 money following such designation, to be expended for the purposes and upon  
28 the authorizations in said Ordinance set forth:”
