5. General description or background of proposed request. Attach executive summary if more space needed:

State law requires City Council approve a service plan for a new metropolitan district, or an amendment to a service plan for an existing district. The DC Metropolitan District (the "District") is located northeast of downtown in the Gateway/Green Valley Ranch neighborhood. The boundaries of the proposed District would be Peña Blvd. to the west, Green Valley Ranch Blvd. to the north, Telluride St. to the east, and a proposed extension to 45th Ave to the south. The District will provide for the construction, financing, installation, operation, and maintenance of public improvements necessary to support the development of the property located within its boundaries, which is anticipated to include two hotels totaling 236 beds, 25,000 square feet of retail/commercial space, 290 multi-family housing units, and 125 for-sale townhomes. It is estimated that the public improvements will cost \$18,000,000. The District will be authorized to impose a maximum mill levy of 50 mills, subject to state legislative and Constitutional changes, and issue up to \$27,000,000 of debt.
