5 **Approving and providing for the execution of a proposed Grant Agreement**
6 **between the City and County of Denver and the Colorado Department of Local**
7 **Affairs (DOLA) concerning the “Strong Communities Infrastructure Grant”**
8 **program the funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
11 Grant Agreement;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
14 **OF DENVER:**

15 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the
16 State of Colorado, Department of Local Affairs (DOLA), for the “Strong Communities Infrastructure
17 Grant” program for “The Denverado at Welton” project, which is identified as Grant Number
18 JHZYLXQAKY33, a copy of which is duly filed with the City Clerk, Filing No. 202474475, CMS No.
19 191603, be and hereby is approved in all respects.

20 **Section 2.** The payments made by the State of Colorado, Department of Local Affairs (DOLA)
21 to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the
22 City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section
23 20-18 of the Revised Municipal Code of the City and County of Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said
25 program, to be expended by the Director of the Department of Housing Stability, is as follows:
