**5. General description or background of proposed request. Attach executive summary if more space needed:**

Approves a map amendment to rezone property from C-MX-5; C-MX-8; and C-MU-30 with waivers and conditions, UO-1, located at approximately 1000 Chopper Circle in Council District 3.

- The property has been subject to the City’s Large Development Review processes since April 5, 2022.
- Notice of receipt of the application was sent on March 29, 2024
- Notice for the Planning Board Public Hearing was sent on July 2, 2024
- Planning Board voted 6-0 to recommend approval the application on July 17, 2024. There were many public speakers. Some spoke in favor of the rezoning based on its economic impact, potential connectivity to downtown from surrounding neighborhoods, and the proposed agreements in the development agreement and proposed community benefits agreement. Some speakers voiced conditional support, advocating that Planning Board vote yes, but withholding their support for Council approval until a community benefits agreement has been executed. The applicant anticipates executing the community benefits agreement prior to the committee hearing date on September 11, 2024.
- To date we have received 1 letter of support from an applicable RNO, LoDo District Inc. They noted the sites potential connectivity, the applicable design guidelines, and the transformative economic impact of the site.
- To date we have received 5 general letters of support noting the affordable housing requirements and the transformative economic impact of the site.
- To date we have received 7 letters of conditional support. Each of those letters offered their support for the overall rezoning and development vision but on the condition that the applicant has executed a community benefits agreement before City Council votes on the application and associated actions.
