

**FIRST AMENDMENT TO
AGREEMENT
MOUNTAIN WEST SERIES OF LOCKTON COMPANIES, LLC**

THIS FIRST AMENDMENT TO AGREEMENT with MOUNTAIN WEST SERIES OF LOCKTON COMPANIES, LLC, is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (“City”), and **Mountain West Series of Lockton Companies, LLC**, whose address is 8110 East Union Avenue, Ste. 700, Denver CO 80237 (the “Consultant”), collectively the “Parties”.

WITNESSETH:

WHEREAS, the Parties entered into an Agreement identified by the City’s Contract number CSAHR-202053662-00 (“**Agreement**”); and

WHEREAS, the Parties desire to amend the Agreement to add two years to the termination date and to increase the maximum contract amount by \$430,000 for a new contract maximum of \$1,455,000.

NOW, THEREFORE, in consideration of the premises, the mutual agreements herein contained, and subject to the terms and conditions hereinafter stated, the Parties agree as follows:

1. That Paragraph 2 entitled “**TERM**”, the first sentence is hereby modified to read as follows:

TERM: The term of this Agreement shall commence upon final execution by all parties, and shall expire at 11:59:59 p.m. on December 31, 2026, unless this Agreement is terminated earlier as provided in this Agreement or is extended as provided in a separate written amendment to this Agreement (“**Term**”).

2. That paragraph 3.A. entitled “**Maximum Contract Amount**” the first sentence is hereby modified to read as follows:

Maximum Contract Amount: The Maximum Contract Amount to be paid by the City to the Consultant shall in no event exceed the sum of **One Million Four Hundred Fifty-Five Thousand and No/100 Dollars (\$1,455,000.00)** unless this Maximum Contract Amount is increased by written amendment to this Agreement.

3. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.


