Emergency security personnel services consist of security service outside of normal programmed scheduled services covered under the citywide security personnel services contract. Emergency service requests will be limited duration service engagements such as providing service for cold weather sheltering sites when activated. The initial contract term will begin on January 1, 2025 to December 31, 2025. The term may be extended for two (2) one (1) year renewal terms upon written amendment prior to the expiration of the current term.
