This is a minor amendment of Chapter 30 of the DRMC, the Landmark Ordinance, to align with the proposed 2024 Text Amendment Bundle for the Denver Zoning Code (DZC). This amendment would repeal Sec. 30-50 Parking, which focuses on excess parking. This is a rarely used and out-of-date section of the Landmark Ordinance, and with the adoption of the 2024 Text Amendment Bundle, it would contradict the DZC. The amendment of Chapter 30 is following the same adoption schedule as the 2024 Text Amendment Bundle of the DZC.
