**A BILL**

**For an ordinance making a rescission from and an appropriation in the Parks Legacy Capital Improvement Fund to make a cash transfer to the Culture and Recreation Special Revenue Fund Series.**

**WHEREAS**, in 2018, Denver voters approved Ballot Measure 2A, which increased the sales tax rate by 0.25 percentage points starting January 1, 2019, to be spent on various programs and projects that support Parks, Trails and Open Space: and

**WHEREAS**, in 2023 the City and County of Denver signed a Purchase and Sale Agreement from Evergreen-Green Valley Ranch & Telluride Land, L.L.C., for the acquisition of Outlook at GVR – PAD 9 acquisition, an approximately 3.1-acre parcel generally located at 17598 Green Valley Ranch Boulevard in Denver’s Green Valley Ranch neighborhood; and

**WHEREAS**, Ordinance 0844, Series of 2023 approved a transfer from the Parks Legacy SRF to Parks Legacy Improvement Projects Funds to maintain scope of work for current projects and not delay projects due to escalating costs; and

**WHEREAS**, the Department of Parks and Recreation (DPR) has received a donation to support the purchase of the land and no longer needs to use the transferred amount; and

**WHEREAS**, the City desires to rescind from the Parks Legacy Capital Improvement Projects Fund to the Parks Legacy Special Revenue Fund;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Parks Legacy Capital Improvement Fund, Accounting No. 36000, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
