5 **A BILL**

6 **For an ordinance making a rescission from General Fund Contingency and**  
7 **appropriations to agency General Fund budgets.**  
8

9 **WHEREAS**, the Denver Sheriff Department requests \$2,700,000 to support collective  
10 bargaining increases not budgeted in 2024; and

11 **WHEREAS**, the Department of Transportation and Infrastructure requests \$2,500,000 to  
12 support increases to fleet expenses and Passport credit card fees, and unbudgeted pay-equity  
13 adjustments; and

14 **WHEREAS**, the Municipal Public Defender requests \$750,000 to support unbudgeted  
15 personnel costs associated with the juvenile representation ordinance that passed mid-year 2024  
16 and associated staffing, and expenses that came in higher than anticipated related to the conflict  
17 counsel contract; and

18 **WHEREAS**, City Council's Central Office requests \$70,000 for unbudgeted personnel costs,  
19 contracts expenses from the districts, and safety upgrades in the Council Committee room that that  
20 were supposed to be incurred in 2023 but didn't happen until 2024; and

22 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
23 **OF DENVER:**

25 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in  
26 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation  
27 under the heading "Amount Rescinded" and transferred to the General Fund:
