8 **near the intersection of South Sheridan Boulevard and Morrison Road; 3) South**
9 **Sheridan Boulevard, located near the intersection of South Sheridan Boulevard**
10 **and Morrison Road; 4) South Sheridan Boulevard, located near the intersection**
11 **of South Sheridan Boulevard and Morrison Road; 5) South Sheridan Boulevard,**
12 **located at the intersection of South Sheridan Boulevard and Morrison Road; and**
13 **6) South Sheridan Boulevard, located at the intersection of South Sheridan**
14 **Boulevard and Morrison Road.**

15 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
16 the City and County of Denver has found and determined that the public use, convenience and
17 necessity require the laying out, opening and establishing as public streets designated as part of the
18 system of thoroughfares of the municipality those portions of real property hereinafter more
19 particularly described, and, subject to approval by resolution has laid out, opened and established
20 the same as public streets;
