5 **A BILL**

6 **For an ordinance making a rescission from General Fund Contingency and**
7 **appropriations to agency General Fund budgets.**
8

9 **WHEREAS**, the Department of Transportation and Infrastructure requests \$2,500,000 to
10 support expenses related to the Volume Based Pricing program, including truck rentals, overtime
11 personnel costs, and increased fees for disposing waste at landfills; and

12 **WHEREAS**, the Denver Economic Development and Opportunity requests \$1,000,000 for
13 Community Development Block Grant (CDBG) expenses that have been incurred while the city
14 awaits the U.S. Department of Housing and Urban Development’s (HUD) approval of the 2024
15 Consolidated Plan to ensure services are not interrupted; and

16 **WHEREAS**, the Denver Sheriff Department requests \$500,000 to support a net shortfall
17 across prisoner care and jail medical services for Denver Health Denver jail medical; and

18 **WHEREAS**, the Denver County Court requests \$500,000 to support unbudgeted personnel
19 costs and equity increases in 2024 and for increases in on-call language access translation
20 services in the courts; and

21 **WHEREAS**, the Office of Human Resources (OHR) requests \$100,000 to ensure sufficient
22 capacity for OHR to stay within budget for costs related to separation payouts and equity
23 adjustments; and

24 **WHEREAS**, the Board of Ethics requests \$10,000 for unbudgeted personnel costs, primarily
25 due to changes in benefits; and

26 **WHEREAS**, the City’s Internal Billings and Reimbursements Special Revenue Fund
27 requires a total increase of \$1,520,000 for increased Police, Fire, and Human Resources
28 personnel costs at the Airport due to overtime and collective bargaining increases;

30 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**

1 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in
 2 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation
