**A BILL**

**For an ordinance authorizing an appropriation in the High Line Canal/Yale Avenue Fund (38433).**

**WHEREAS**, in July 2022, via ordinance 644, series of 2022, the City Council approved an IGA between the City and County of Denver and The Board of Commissioners of the County of Arapahoe for project cost sharing associated with the High Line Canal trail and road improvement project at Yale Avenue; and

**WHEREAS**, per said agreement, the County of Arapahoe committed to reimburse the City for High Line Canal trail and road improvement project at Yale Avenue project costs; and

**WHEREAS**, the City requires an appropriation for this purpose;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Grant and Other Money Projects Fund, Accounting No. 38000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1682, Series of 2023, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
