5 **Laying out, opening and establishing as part of the City street system parcels of**
6 **land as: 1) Morrison Road, located at the intersection of Morrison Road and West**
7 **Mississippi Avenue; 2) Morrison Road, located near the intersection of Morrison**
8 **Road and West Mississippi Avenue; 3) Morrison Road, located near the**
9 **intersection of Morrison Road and South Utica Street; 4) Morrison Road, located**
10 **near the intersection of Morrison Road and South Stuart Street; 5) Morrison**
11 **Road, located near the intersection of Morrison Road and West Ohio Avenue;**
12 **and 6) Morrison Road, located at the intersection of Morrison Road and West**
13 **Ohio Avenue.**

14 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
15 the City and County of Denver has found and determined that the public use, convenience and
16 necessity require the laying out, opening and establishing as public streets designated as part of the
17 system of thoroughfares of the municipality those portions of real property hereinafter more
18 particularly described, and, subject to approval by resolution has laid out, opened and established
19 the same as public streets;

20 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

21 **Section 1.** That the action of the Executive Director of the Department of Transportation
22 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of
23 the municipality the following described portion of real property situate, lying and being in the City
