A BILL

For an ordinance amending Ordinance No. 1498, Series of 2024 to change the Fund number for the transfer out of Convention Center Special Revenue Fund to Fund 15607.

WHEREAS, Ordinance No. 1498, Series of 2024, create the “Colorado Convention Center Revenue Projects” Fund to account for capital projects at the Colorado Convention Center (CCC) and authorized the transfer of cash from the Convention Center Special Revenue Fund (15607) to the “Colorado Convention Center Revenue Projects” Fund; and

WHEREAS, an incorrect fund number was used in the Section 4 table for the transfer out; and

WHEREAS, this ordinance seeks to correct said Fund without making changes to the approved appropriations;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Section 4 is hereby amended to read as follows:

“There is hereby authorized the transfer of cash from the “Convention Center Special Revenue Fund (15607) to the Colorado Convention Center Revenue Projects” Fund the amount indicated in the following tabulation:
