The parking garage at 1375 Delaware Street was constructed for the Lindsey-Flanigan Courthouse as a condominium with USPS (first floor) and DPS (fifth floor) as condo owners together with the City. DPS (School District No. 1) has signed a Contract to Buy and Sell Real Estate to sell the fifth floor to the City for \$1,800,000. Acquisition of the fifth floor by the City will provide needed parking to support the courts including jurors and adjacent City services. After acquiring the fifth floor, the City will own a portion of the first floor and floors 2-5.
