

Interagency Agreement between the Office of Climate Action, Sustainability, and Resiliency (CASR) and the Denver Police Department (DPD) for a pilot of one EV Chevy Blazer PPV and one Chevy Silverado EV, as well as supplementary equipment and training to ensure the success of the pilot.

Overview

In pursuit of innovative mobility projects, CASR is interested in funding the purchase of 1 (one) 2025 Chevy Blazer EV AWD 4dr 2FL Police (Chevy Blazer PPV) and 1 (one) Chevy Silverado EV e4WD Crew Cab Extended Range LT (Silverado EV), equipment tooling, and training to for the maintenance of these vehicles.+ DPD would purchase, manage, and operate these vehicles. These vehicles would serve as pilot projects and would allow DPD to test EV technology, paving a way for routine purchase of EVs for DPD operations.

While light-duty vehicles, such as those used by DPD for routine City operations, are prime candidates for electrification, DPD's vehicles operate under unique circumstances in emergency response, such as long idling time, dynamic driving, prisoner transportation, custom up-fitting, take home use with after hours emergency response, and other special requirements. Further, a technology failure limiting emergency responsiveness has the potential to be more consequential than other types of City service interruption. Due to these factors, it is important to pilot EVs for police use to set the stage for wider adoption of EVs within DPD. Additionally, as these vehicles operate throughout Denver's neighborhoods every week, there are community health and wellbeing co-benefits in line with CASR's environmental justice goals. These vehicles will be tested in the full range of DPD operations, helping CASR understand the best opportunities for integrating EVs into DPD's fleet. This funding would come from the Climate Protection Fund to promote sustainable mobility through a demonstration of EV technology for City operations. Without this funding, this electric vehicle pilot would not take place.

Alignment with the CPF Transportation Allowable Use

CPF's Sustainable Transportation Allowable Use Definition

Programs and services that provide affordable, clean, safe, and reliable transportation choices, like walking, biking, transit, electric vehicles, and neighborhood-scale transit.

CPF's Workforce Allowable Use Definition

Job creation through local workforce training and new careers for under-resourced individuals in clean energy technology and management of natural resources.

Chevy EV Blazer PPV and Silverado EV Pilot Attributes and Justification

- CASR will cover the purchase of 1 Chevy Blazer PPV and 1 Chevy Silverado EV for DPD, up to \$138,686
 - DPD will purchase and place vehicles into service
 - These vehicles will be expansions to the DPD fleet

- The Chevy Blazer PPV costs \$56,996, the cost breakdown can be found in appendix A.2 of this IAA
 - The Silverado EV costs \$81,690, the cost breakdown can be found in appendix A.1 of this IAA
- CASR will cover the upfit costs associated with these vehicles, up to \$18,200
 - Upfit cost of EV Blazer, Slick top, no cage: \$13,000
 - Upfit cost of Silverado EV: \$5,200
 - A screenshot of these estimates from BearCom is included in Appendix A.3 of this IAA
- CASR, through a separate contract mechanism, will coordinate with DPD to ensure adequate charging is available for these vehicles if needed
 - CASR is not responsible for fueling costs
- CASR will support the maintenance and training costs associated with these vehicles, including by supporting the following categories, up to \$100,000
 - Upgrades to ready-to-convert maintenance bay space at Roslyn to EV-ready station, so that technicians are able to safely work on EVs
 - Service Center upgrades to accommodate EV maintenance and diagnostics
 - EV specific non-conductive tools, gloves, etc.
 - PPE materials to ensure the safety of the fleet technician
 - Diagnostic tools and subscriptions
- CASR will also help source and review training programs for mechanics to receive EV training certifications, enabling them to provide a real-world test of the total costs of this program, up to \$8,700
 - Training Subscriptions and initial and ongoing trainings
 - EV specific tooling
 - Training of fleet managers to enable them to train future fleet technicians
 - Training programs will be created to ensure standardization across City fleets and compliance with Climate Protection Fund allowable uses
- CASR is including a contingency budget for this pilot project up to \$14,414. These funds are in light of the real-world nature of trainings, tools, and other costs which vary over time. While it is not expected that DPD need use these funds, they are included here as contingency should additional need arise. DPD must make a written request to use these funds prior to their disbursement.
- DPD is responsible for the purchase, management, and operation of these vehicles, including all costs not covered explicitly within this IAA
- DPD will make all non-law enforcement or DPD sensitive data gained over the course of the pilot available to CASR staff available in reports on at least a twice-annual basis to ensure CASR is able to fulfill its reporting requirements
- Report information will include, but is not limited to:

- Average daily charge time
- Average shift length
- Use case (administrative non-emergency, patrol, etc.)
- Total mileage and average miles driven per day
- Operational successes or challenges with the vehicle (too small, no space for prisoners, charging times, etc.)
- Cost of ownership, including maintenance costs and labor
- This project is a rapid action that could lay the groundwork for future heavy-duty EV procurements, helping the City reach its climate goals.

CPF Budget Contribution

Contribution

CASR agrees to contribute up to \$160,000 from the Sustainable Mobility cost center and \$120,000 from the Workforce cost center (total of \$280,000) of the Climate Protection Fund in support of the project.

Disbursement

CASR will coordinate with DoF to apply CPF funding from CASR's Sustainable Mobility fund for the procurement and maintenance of the two pilot vehicles in accordance with the details of this agreement.

Equity Value

CASR is required to report on the equity value of its investments made via the CPF. The equity value of this contribution is valued at 20% of the \$280,000

Reporting

CASR's funding of this pilot includes the expectation that CASR will be included in the creation of the pilot and ongoing meetings, and will have access to performance updates and evaluations. DPD will provide updates to CASR that includes updates on the impact of this investment for use in CASR's annual report on the Climate Protection Fund. This includes a Q2 and Q4 update no later than July 30, 2025 and January 31, 2026, and similar updates for future Q2 and Q4 reports, as requested by CASR and dependant on delivery dates.
