

## **FIRST AMENDATORY AGREEMENT**

**THIS FIRST AMENDATORY AGREEMENT** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **MALONEY TREE CARE, LLC**, a Colorado limited liability company, with an address of 303 S. Broadway, Suite 200 #710, Denver, Colorado 80209 (the “Contractor”), jointly “the Parties.”

### **RECITALS**

**A.** The Parties entered into an Agreement executed on June 12, 2024 (the “Agreement”) for the performance of certain work set forth in that Agreement and the exhibits thereto; and

**B.** The Parties wish to amend the Agreement to modify the rates for work in order to continue the services.

**NOW, THEREFORE**, the Parties hereby amend the Agreement as follows:

**1.** All references to “Exhibit B” (as related to the Agreement) shall be amended to read: “Exhibit B-1”. The rates and requirements in Exhibit B-1 are hereby incorporated herein by reference and shall supersede and replace the rates and requirements in Exhibit B.

**2.** Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

**3.** This First Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.


