

AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT (this “Amendatory Agreement”) is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”), and Flatiron Dragados Constructors, Inc., a Delaware corporation, formerly known as FLATIRON CONSTRUCTORS, INC., with an address of 385 Interlocken Crescent Blvd, Suite 900, Broomfield, CO 80012 (the “Contractor” and referred to herein, together with the City, as the “Parties”).

RECITALS

A. The Parties entered into that certain Contract No. 202472375, dated March 28, 2024 (the “Agreement”), regarding certain on-call bridge construction services to be provided by the Contractor in the City and County of Denver, Colorado.

B. The Contractor has advised the City that the Contractor has changed its formal legal name and the Parties now wish to amend the Agreement to reflect the correct current entity name.

NOW, THEREFORE, the Parties hereby amend the Agreement as follows:

1. The formal legal name of the Contractor is: Flatiron Dragados Constructors, Inc., a Delaware corporation. The Contractor represents that this action is a name change only and does not represent an assignment or other transfer of the Agreement from one legal entity to another.

2. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

3. Contractor consents to the use of electronic signatures by the City. This Amendatory Agreement, and any other documents requiring a signature hereunder, may be signed electronically by the City in the manner specified by the City. The Parties agree not to deny the legal effect or enforceability of this Amendatory Agreement solely because it is in electronic form or because an electronic record was used in its formation. The Parties agree not to object to the admissibility of this Amendatory Agreement in the form of an electronic record, or a paper copy of an electronic document, or a paper copy of a document bearing an electronic signature, on the ground that it is

an electronic record or electronic signature or that it is not in its original form or is not an original.

4. This Amendatory Agreement will be effective upon execution by both Parties.
