Indigenous Peoples' Day in Denver

- Historically, the second Monday of October has been recognized as Columbus Day at the federal and state level
- Columbus Day is not recognized in the City & County of Denver.
- The first city to recognize Indigenous Peoples' Day on the second Monday of October is Berkeley, CA in 1992.
- In 2015, Seattle and Minneapolis each passed resolutions to recognize Indigenous Peoples' Day in their respective cities.
- South Dakota recognizes the second Monday of October as Native Americans Day and the State of Alaska has recently recognized the second Monday of October as Indigenous Peoples' Day
- Last year and this year many more cities have joined the list of recognizing Indigenous Peoples' Day
- Councilman Paul D. Lopez (Dist. #3) Introduces a City and County of Denver Proclamation No. CP15-0761 **Proclaiming October 12, 2015 as "Indigenous Peoples' Day" in Denver, Colorado**

The DAIC would like the City & County of Denver to establish **Indigenous Peoples' Day** on the 2nd Monday of every October through ordinance

Denver is located on the ancestral homelands of 48 tribes, and is currently the home to descendants of the Cheyenne, Lakota, Kiowa, Navajo, and approximately 100 other tribal nations

- DAIC firmly believes that the positive outcomes of recognizing Indigenous Peoples' Day in the City & County of Denver will be:
 - Unifying and educating Denver communities
 - Creating opportunity to build capacity and partnerships in Denver and surrounding communities
 - Promoting knowledge about and respect of Indigenous peoples
 - Combating prejudice and helping to eliminate discrimination against Indigenous peoples
- DAIC plans to host cultural and educational events to celebrate Indigenous Peoples' Day in the City & County of Denver
