11	BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:				
12	Section 1. Upon consideration of the re	ecommendation of the Manager of Public Works that			
13	an ordinance be enacted for the purpose of assessing the annual costs of the continuing care,				
14	operation, repair, maintenance and replacement of the Consolidated Larimer Street Pedestrian Mall				
15	Local Maintenance District ("Consolidated Larimer Street Pedestrian Mall"), for the upcoming year,				
16	upon the real property, exclusive of improvements thereon, benefited, the Council finds, as follows:				
17	(a) A local maintenance district pro	viding for the continuing care, operation, repair,			

maintenance and replacement of the Consolidated Larimer Street Pedestrian Mall, was created by
Ordinance No. 779, Series of 1997;

(b) The annual cost of the continuing care, operation, repair, maintenance and
 replacement of the Consolidated Larimer Street Pedestrian Mall is \$27,120.00, which amount the
 Manager of Public Works has the authority to expend for the purposes stated herein;

(c) The Manager of Public Works has complied with all provisions of law relating to the
publishing of notice to the owners of real properties to be assessed and to all persons interested
generally, and the Council sitting as a Board of Equalization has heard and determined all written
complaints and objections, if any, filed with the Manager of Public Works;

(d) The real property within the Consolidated Larimer Street Pedestrian Mall will be
benefited in an amount equal to or in excess of the amount to be assessed against said property
because of the continuing care, operation, repair, maintenance and replacement of said Streetscape.

30 **Section 2.** The annual cost of the continuing care, operation, repair, maintenance and 31 replacement of the Consolidated Larimer Street Pedestrian Mall to be assessed against the real 32 properties, exclusive of improvements thereon, benefited are hereby approved.

33 **Section 3.** The annual costs of the continuing care, operation, repair, maintenance and 34 replacement of the Consolidated Larimer Street Pedestrian Mall in the amount of \$27,120.00 are

- 1 hereby assessed against the real properties, exclusive of improvements thereon, within said local
- 2 maintenance district as follows:
