**A bill for an ordinance to appropriate the 2016 Revenue Based Winter Park  
Parks and Recreation Capital Fund.**

**WHEREAS**, The City has received the revenue-based annual payment from the Winter Park Recreational Association (WPRA) per the terms of the Winter Park Lease and Operating Agreement, in the amount of \$1,486,244;

**WHEREAS**, The City has previously included \$500,000 of the annual payment in the 2016 CIP budget;

**WHEREAS**, the City and County of Denver has identified the projects to be funded by said remaining payment;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY  
OF DENVER:**

**Section 1.** Expenditures are hereby authorized from the Capital Projects Fund, Accounting No. 30000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:
