## **EXECUTIVE SUMMARY**

The purpose of the ordinance is to approve certain amendments to the DUS Metropolitan Districts 1-5 service plans to match the provisions of the new financing at Union Station. State law requires that a public hearing be conducted prior to City Council approving service plan amendments, with publication to commence a minimum of 20 days prior to the hearing.

The loan agreement for the new financing was presented at Finance Committee on January 3<sup>rd</sup> and the ordinance is scheduled for City Council on January 17<sup>th</sup>. The approval of the loan agreement will allow the interest rate to be locked with the banks.

This related ordinance to amend the metro districts service plans is on a traditional schedule as we are seeking approval to amend the service plans prior to loan closing. Below is the City Council schedule for the ordinance approving the DUS Metro districts service plan amendments.
