6. General description of proposed ordinance including contract scope of work if applicable:

This ordinance request wishes to amend three items from contract PWOPS 201209229:

1. The corporation has legally changed their name to Lytx Inc. from DriveCam Inc. We request that the contract be changed to reflect the corporation's current legal name.
2. The original duration of the contract was for two years, April 1, 2013 through March 31, 2015, followed by three automatic one year renewals unless the corporation was notified that the City wished to cease receiving services. We request that the duration be changed to begin on April 1, 2013 and end on March 31, 2018. This would correspond to the originally planned start and end dates and formalize a five-year commitment.
3. The Lytx camera system is a windshield or cab mounted dual lens system that records video of drivers and forward traffic conditions. Twelve second video clips are transmitted only when there is an event that causes a sudden change in vehicle movement such as hard braking, rapid acceleration, swerving, or an impact. These videos It is used to identify potentially dangerous driving behaviors and allow for collective review by a driver and supervisor in order to create behavioral driving change to reduce injury, risk, and liability to employees, City owned vehicles, and other parties. It is currently used by such businesses and agencies as the U.S. Department of State, U.S. Foods, Waste Connections Inc., Orange County Florida, US Concrete, and others.

Numerous benefits have been realized by the City since the program's inception. Both the number and severity of accidents within the Solid Waste Division of Public Works has fallen by roughly half, City employees have been exonerated when collisions did occur where other parties were at fault, allowed the City to contest claims of property damage, reduced behaviors that increase the likelihood of accidents such as following too closely to other vehicles, reduced research and litigation and resolution times when accidents do occur, and allowed our Safety teams to improve training by incorporating videos into their training¹. Such positive results in the Solid Waste Division have resulted in a more recent expansion of the program to the City's Right of Way Enforcement (ROWE) Agency in 2015.

We request an increase in total allowable expenditures of \$320,814.85 from an original amount of \$466,903.29 for a new total of \$787,718.14. This will allow for payment of annual subscription fees of the 217 camera systems currently in use through the duration of the contract as well as the acquisition of sixteen additional cameras for ROWE.
