7 For an ordinance amending sections 6-206 and 24-508, Denver Revised Municipal
8 Code regarding the hours of operation of retail marijuana stores and medical marijuana
9 centers.

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** That subsection (d) of section 6-206, D.R.M.C. shall be amended by deleting the
13 language stricken and adding the language underlined, to read as follows:

14 **Sec. 6-206. - Unlawful acts.**

16 (d) It shall be unlawful for any person to sell marijuana or marijuana products at a
17 licensed retail marijuana store at any time other than between the hours of 8:00
18 a.m. and ~~7:00 p.m.~~ 12 midnight daily.

20 **Section 2.** That subsection (e) of section 24-508, D.R.M.C. shall be amended by deleting the
21 language stricken and adding the language underlined, to read as follows:

22 **Sec. 24-508. - Licensing requirements—Medical marijuana centers.**

24 (e) *Hours of operation.* It shall be unlawful for any person to sell medical
25 marijuana or medical marijuana products at a licensed medical marijuana
26 center at any time other than between the hours of 8:00 a.m. and ~~7:00 p.m.~~ 12
27 midnight daily.
