Support leases are not selected competitively because the lease is ancillary to, and in support of existing lease agreements; accordingly, office and support space leases create special circumstances exempting them from competitive selection, as provided for in Paragraph 3 of Memorandum 8B.

This is a revenue agreement which seeks to lease office space to a company contracted with, and providing services to, several airlines operating at DEN, and is exempt from the competitive selection requirements.

They will be leasing approximately 312 square feet of office space on the apron level of Concourse A to support their operation. Rent will be \$50,458.00 annually, but is published in DEN's Rates and Charges and can be adjusted annually.
