Environmental Learning for Kids (ELK) is seeking \$500,000 in grant funding from GOCO to go towards the construction of a 7,000 square foot ELK Education Center (ELK EC) on one acre of a restored 5.5 acre property located at 12680 E. Albrook Drive in Montbello neighborhood. The vision is a community-based environmental educational center with a destination natural area. Inclusive in the acreage is an important terrestrial and aquatic habitat, walking trails, interpretative kiosks, and areas for science and environmental education. The project will result in educational, environmental, citizen stewardship, and community benefits. Funding to build the ELK EC assists in providing youth in areas of the northeast corridor of our City access to opportunities and the support they need to become successful and self-sufficient including science, math and environmental education.

As part of the Northeast Metro Coalition, Parks & Recreation will pass-through GOCO grant funds to Environmental Learning for Kids for their future education center.
