Section 1. That subsection (d) of section 6-206, D.R.M.C. shall be amended by deleting the				
language stricken and adding the language underlined, to read as follows:				
Sec. 6-206 Unlawful acts.				
(d) It shall be unlawful for any person to sell marijuana or marijuana products at a licensed retail marijuana store at any time other than between the hours of 8:00 a.m. and 7:00 p.m. <u>10:00 p.m.</u> daily.				
Section 2. That subsection (e) of section 24-508, D.R.M.C. shall be amended by deleting				
the language stricken and adding the language underlined, to read as follows:				
Sec. 24-508 Licensing requirements—Medical marijuana centers.				
 (e) Hours of operation. It shall be unlawful for any person to sell medical marijuan or medical marijuana products at a licensed medical marijuana center at any time other than between the hours of 8:00 a.m. and 7:00 p.m. <u>10:00 p.m.</u> daily. 				
Section 3. This ordinance shall be effective Monday, May 1, 2017.
