FIRST AMENDMENT TO REVENUE AGREEMENT

THIS FIRST AMENDMENT TO REVENUE AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and COLORADO INTERACTIVE, LLC, a Colorado Limited Liability Company, whose address is 600 17th Street, Suite 2150, Denver, Colorado 80202 (the "Contractor"), jointly "the Parties."

WITNESSETH:

WHEREAS, the Parties entered into an Agreement dated August 31, 2015 (the "Agreement"), to develop, install, operate, quality manage and maintain a payment and billing solution for the City that integrates with their proprietary e-filing and case management applications and provides customer and user account registration, transaction processing, customer account billing, common payment options and comprehensive reporting features; and

WHEREAS, the City currently estimates that it will collect \$108,900.00 on an annual basis; and

WHEREAS, the Parties wish to amend the Agreement to extend the term and append fee terms.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- 1. Article 2 of the Agreement entitled "TERM" is amended to read as follows:
 - "2. <u>TERM</u>: The term of the Agreement is co-terminus with the SIPA Agreement, and beginning on January 12, 2015 and expiring on March 31, 2021."
- **2.** The attached Fee Agreement is incorporated herein.
- **3.** Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

1. BACKGROUND

Denver County Court is developing an eFiling system that will integrate with Colorado Interactive's payment and billing applications, as outlined in Work Order 00000892. All Denver County Court transactions will fall under service code dcc_efile in Colorado Interactive's Transaction Payment Engine (TPE).

2. TRANSACTION REQUIREMENTS

Several different transaction types will be created through the Denver County Court application, which include case access, notifications, filings and services.

2.1 Transaction Fee Table

The table depicts the fee information for all transaction codes to be used when creating a TPE order. Each Fee Code will be represented in TPE as a unique item SKU code. The fees depicted in the following table are NOT configured within the TPE application. The Denver County Court applications will be responsible for passing the fee amount to TPE for each transaction, including \$0 fees when applicable.

2.2 Invoice Payment Surcharge

Colorado Interactive is in the process of implementing an invoice payment surcharge with the State Courts. The surcharge will cover the cost of processing invoice payments online. For credit card payments, the surcharge will be approximately 2.17% of the invoice amount, with the exact percentage to be determined prior to implementation. When the surcharge is implemented for the State Courts, the same surcharge will be applicable for Denver County Courts transactions. A separate surcharge fee agreement will executed, with the exact surcharge percentage for credit cards, prior to implementation.
