## SIXTH AMENDATORY AGREEMENT

**THIS SIXTH AMENDATORY AGREEMENT** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City"), and **SMG**, a Pennsylvania general partnership, whose local address is 700 14th Street, Denver, Colorado 80202 (hereinafter referred to as "SMG") (together, the "Parties").

**WHEREAS**, the City and SMG wish to amend the pension and HW benefits set forth in Exhibit B-3 (SMG Stagehand Payroll Administrative Markup) to this Agreement as follows; and

**NOW, THEREFORE,** in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- 1. Exhibit B-3 to the Agreement is hereby deleted in its entirety and replaced with Exhibit B-4, attached hereto and incorporated herein. All references to "Exhibit B-3" in the Agreement are hereby amended to read "Exhibit B-4".
- 2. As herein amended, the Agreement is affirmed and ratified in each and every particular.
