## FIRST AMENDMENT TO DATA ACCESS AGREEMENT

THIS FIRST AMENDMENT TO DATA ACCESS AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and LexisNexis VitalChek Network, Inc., a Tennessee Foreign Corporation, with its business address of 6 Cadillac Drive, Suite # 400, Brentwood, TN 37027 (the "Customer"), collectively "the parties".

## RECITALS

- A. The Parties entered into a Data Access Agreement dated July 21, 2016 (the "Agreement"), relating to, on behalf of the Denver County Court, providing access to the public information on the Database.
- **B.** The Parties acknowledge that the City has received \$317,653.00 in total revenues since the Agreement commenced in 2016.
- **C.** The parties anticipate that from June 24, 2017 through June 24, 2021, the revenue paid to the City will be \$2,227,404.00.
- **D.** The parties also acknowledge that under § 3.2.6. of the City's Charter, all contracts, including amendments, that will require or result in payment by or receipt of \$500,000 or more by the City, must be approved by City Council before the City executes the contract.
- **E.** The Parties wish to amend the Agreement to extend the term as set forth below.

In consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

Article 5(a) of the Agreement entitled "<u>TERM AND TERMINATION</u>",
"Term" is amended to read as follows:

## **"5. <u>TERM AND TERMINATION</u>**

(a) <u>Term</u>: The term of the Agreement commences upon June 24, 2016 and expires on June 24, 2021, unless extended in accordance with the terms of the Agreement, or unless earlier terminated upon the first to occur of any of the events listed in the Agreement ("Term"). The events listed in the Agreement are referred to as "Event of Termination."

2. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.
