Project Title: 2017-VACA-0000010 STREET RENAME Market Place St. to S. Market Place St. correction to Broadway Station Filing No. 1

Owner name: CCD

Description of Proposed Project: A new public Metro District right of way, lying south of W. Kentucky Ave. and north of W. Mississippi Ave., one block west of S. Broadway, was created by a subdivision plat titled "Broadway Station Filing No. 1" on May 24, 2017, and recorded at reception #2017068642. On the plat, the right of way was named "Market Place St.".

It was later discovered that this right of way should have been given the prefix "S." because it lies in the south half of the city grid. This oversight constitutes a scrivener's error and must be corrected to be in conformance with CCD addressing and street naming standards.


Fortunately, no properties have been issued addresses at this time. Also, all of the parcels having access from the new right of way have the same ownership. Site Development Plans are currently under review for some of the lots in this subdivision. Rectifying this situation prior to issuance of any addresses is in everyone's best interest.
