Packard's Hill proposed historic district, West Highland, Dist. 1 Bill 17-0903 for final hearing on Monday, September 25th

We are sending this information regarding our outreach for the proposed Packard's Hill Historic District. The proposed designation of Packard's Hill enjoys a high level of support (over 78%) among property owners who have taken a position. These owners recognize that the neighborhood character and history form part and parcel of what they value about their homes, their location, and their property. Supporters believe preservation & complementary development are good for homeowners. They also appreciate the special history, especially women's history, represented in the neighborhood, and the highly intact collection of historic architecture from the late 19th and early 20th century. The proposed district meets or exceeds all necessary requirements for passage.

The high level of support from 76 of the 97 properties who took a position is the result of extensive outreach.

The neighborhood outreach team has done an incredibly thorough and exhaustive job reaching out to neighbors, fostering conversation, and answering questions.

Among other efforts, volunteers have:

- Completed numerous rounds of individual property door knocking
- Held block coffees for all property owners
- Sent five mailings to the registered street address for each property
- Sent 24 emails to all property owners who had shared an email address
- Distributed at least 10 informational flyers and handbills, in addition to creating a website
- Organized two walking tours, one research meeting
- Held two larger informational public meetings with expert panels

Overall, 107 properties responded, translating to a response rate above 55%.

As anyone knows who has knocked on doors and asked for a commitment, it's very challenging to get to an <u>over 55% response rate</u> (incl. supportive, opposed, some other answer - 10 respondents chose not to take a position).

We are proud to present you with our application for inclusion as a Denver Landmark District and we hope our efforts will be rewarded with passage of this bill.




