
PROPOSAL TO OFFICIALLY NAME CARPIO-SANGUINETTE PARK

To Honor Neighborhood Heritage

To Celebrate Our Community Leaders

THE PARK

- 13-acre, award-winning, community park
 located in Globeville neighborhood
- Replaced wastewater treatment plant
- The land was once vital, fertile farmland
- Park is adjacent to Heron Pond/Heller Open
 Space and is bordered by the South Platte
 River, Emerson Street, and 53rd Avenue
- Part of a 100-acre park master plan
- Globeville community wanted this park named before changes in neighborhood occur due to extensive development



NORTHSIDE WASTEWATER TREATMENT FACILITY



Northside Wastewater Sewage Treatment Facility

- Built in 1937 on farmland and along the South Platte
 River
- After the facility closed, the property was a blight on the Globeville community for over a decade
- Property was so blighted it was used as a backdrop in the Sci-Fi movie, "Asteroid"
- Parts of the facility's concrete barriers were incorporated into the park. This created the park's unique design, won national awards, and saved money on construction costs

THE PARK TODAY





An award winning park

- A community park and neighborhood asset used daily by north Denver residents for picnics, soccer games, walking, and relaxing
- Adjacent the South Platte River bike path
- Currently has no official name Northside is the name of the old wastewater treatment facility
- Quotations from the community are etched into the structures as part of the park's design
- Changing demographics of residents due to development from many publicly and privately funded projects

REASONS TO RENAME THE PARK

• Carries forward a shared history of stewardship and protects the neighborhood's past as changing demographics impact this area.

• Sal Carpio and the Sanguinette family were leaders in the Globeville and Elyria Swansea communities and Denver. Their civic, communal, and cultural contributions deserve preservation to inspire future leaders.

 Community leaders should be recognized in the areas they helped build. The renaming recognizes the importance of Sal Carpio and the Sanguinette family in their community, to the Denver Parks and Recreation system, and to the City and County of Denver.

Naming the park Carpio-Sanguinette Park is suitable, appropriate, symbolic, and historic.

SANGUINETTE FAMILY

A GLOBEVILLE FAMILY


- Pioneering family settled in north Denver in 1850s
- A portion of the park was part of the Sanguinette farm located on South Platte River
- Family operated a north Denver grocery that sold area produce
- Led fight to stop upstream slaughterhouses dumping waste into Platte River
- Sanguinette descendants still live in Globeville







SAL CARPIO



VISIONARY LEADER

- Salvadore 'Sal' Carpio's roots are in Globeville
- Raised in Globeville in early years
- Denver Public School Teacher
- Metro State College of Denver Professor of Sociology
- Denver City Councilmember, 1975-1987
- One of Denver's first Latino city council members (along with Sam Sandos)
- Master at securing city and state resources for District 9
- Served as council president
- Authored Registered Neighborhood Notification Ordinance in 1976 that empowered neighborhood organizations
- Catalyst for redevelopment of Central Platte Valley abandoned railroad land an area now home to DaVita, Union Station, over 10,000 residential units, and much more

SAL CARPIO



COMMUNITY LEADER

- Established numerous city parks: Commons, Cuernavaca, Confluence, among others - including Northside park
- Established nine community centers in his council district
- Executive Director of Denver Housing Authority (1994-2007)
- Modernized several Denver housing developments, including Quigg
 Newton, Curtis Park, North Lincoln Park
- Efficient steward of federal housing funds
- Nationally recognized for his leadership of DHA
- Many of his DHA initiatives adopted by Federal Housing and Urban Development

COMMUNITY SUPPORT

The petition to name the park received overwhelming community and civic support.

Over 650 signatures were submitted

In accordance with the procedure established by the Denver Board of Parks & Recreation, the undersigned hereby petition the Board to recommend the renaming of Northside Park to Carpio-Sanguinette Park. This park sits generally between 51st and 53rd Avenues and the Colorado Guard Armory on the northeastern side of the park and the South Platte River on the southeastern side of the park – See attached site map. In support of this petition, each of the undersigned affirms and states:

- 1. That he/she is lives in the City and County of Denver (at time of signature).
- That he/she supports the proposed name.

Sal Carpio was a dedicated public servant who represented District 9 on Denver City Council for 12 years. He championed the Globeville neighborhood where he lived as a small child, and was the author of Denver's Neighborhood Notification Ordinance, as well as many infrastructure improvements. Sal Carpio also made significant contributions to the Denver park system during his tenure on Council, including establishment of Northside Park. Louis Sanguinette owned 10 acres of farmland east of Washington Street between 50th and 51st Streets, Portions of the original Sanguinette farm are now part of the park. The Sanguinette family represents the thousands of immigrants who made Globeville their home and whose descendants main in the community.


