WHEREAS, in accordance with the procedure established by the Department of Parks and Recreation's Naming Policy, a petition was initiated by Councilwoman Deborah "Debbie" Ortega and signed by 666 individuals to rename Northside Park as "Carpio-Sanguinette Park," with twenty (20) letters or emails of support from Wellington Webb, former Denver Mayor, Rudy Gonzales, Federico Pena, former Denver Mayor; Dr. Patricia "Patty" Baca, former Denver Public Schools Administrator;

Patricia A. Salazar, Sal Carpio's wife, and his family; Louis and Debbie Gomez, Sanguinette family
 relatives; and three (3) longtime Denver residents; and

3 **WHEREAS**, in support of the petition, Wellington Webb stated: "As this area of Denver 4 changes, it is important to remind our longtime residents and newcomers of our pioneers and leaders 5 who worked decades for the neighborhoods who use this park"; and

6 WHEREAS, Frederico Pena wrote: "My greatest admiration of Sal Carpio stems from his 7 renowned honesty integrity and devotion to the people of Denver. He is truly deserving of this honor 8 and the renaming of this park will serve as an inspiration to many Northside youth to work hard, 9 dream big, and contribute to their city"; and

10 WHEREAS, Paula E. Sandoval, a longtime Denver resident, stated: *"[Renaming the park] will* 11 *unite the history of the two cultures and two distinguished families and I cannot think of a better way* 12 *to honor and remember them."*

13 **WHEREAS**, the Executive Director of the Department of Parks and Recreation supports the 14 proposed renaming of this park and the Denver Parks and Recreation Advisory Board voted at its 15 meeting on June 14, 2017, to recommend the renaming of Northside Park to ""Carpio-Sanguinette 16 Park."

17 BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That Northside Park be and the same is hereby renamed, and shall be known
 as Carpio-Sanguinette Park.
