Section 1. That the Budget and Work Plan for the 2018 budget year for the District as filed in the Office of the City Clerk on the 5th day of October, 2017, Filing No. 2005-0860-T be and hereby is adopted and approved for the 2018 budget year. That the estimated revenues and expenditures for the District's General Fund, the Debt Service Fund, and the Capital Projects Fund for fiscal year 2018, as more specifically set forth in the Budget, are adopted and approved.
