Holly Street. This agreement with KRF Holly, LLC is contingent upon the City closing on the purchase with CDOT. The property is approximately 11.11 acres. The City's purpose for entering into this transaction with KRF Holly, LLC is the catalytic development of the property ensuring development consistent with existing neighborhood, area plans, and economic and job development within the City and County of Denver. Buyer plans to develop 225 walk up housing units to be sold at market rate and develop 50-80 units for senior housing. The City will advance \$243k (refundable) at execution to be paid with Real Estate funds with KRF Holly, LLC placing \$210,000 in escrow. Contract amount is \$5,250,000.
