### FIRST AMENDMENT TO ON-CALL SERVICES AGREEMENT

THIS FIRST AMENDMENT TO ON-CALL SERVICES AGREEMENT by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and TRUEPOINT SOLUTIONS, LLC, a Nevada company, registered to do business in Colorado, whose address is 774 Mays Blvd 10-377, Incline Village, NV 89451 ("Contractor").

#### **WITNESSETH:**

**WHEREAS**, the Parties entered into an Agreement dated December 14, 2016 (the "Agreement"), relating to providing maintenance and support services; and

**WHEREAS**, the Parties wish to amend the Agreement to extend the term and increase the compensation to the Contractor.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- 1. Article 3 of the Agreement entitled "**TERM**" is amended to read as follows:
  - "3. <u>TERM</u>: The term of the Agreement is from December 1, 2016 through December 31, 2020."
- **2.** Article 4(D)(i) of the Agreement entitled "Maximum Contract Liability" is amended to read as follows:

# **"4.** COMPENSATION AND PAYMENT:

## **D.** Maximum Contract Liability:

- (i) Any other provision of this Agreement notwithstanding, in no event shall the City be liable for payment for services rendered and expenses incurred by Contractor under the terms of this Agreement for any amount in excess of the sum of TWO MILLION FOUR HUNDRED NINETY-NINE THOUSAND NINE HUNDRED NINETY-NINE DOLLARS AND ZERO CENTS (\$2,499,999.00). Contractor acknowledges that any work performed by Contractor beyond that specifically authorized by the City is performed at Contractor's risk and without authorization under this Agreement."
- 3. Except as herein amended, the Agreement is affirmed and ratified in each and

every particular.
