To understand, here's the big picture of the problems with water:

The President was a victim of heavy metal poisoning as a child. Lead causes stupidity, bullying, criminal and sexual aggression which accounts for his. Gary Wockner: Colorado Water Plan has become 'Colorado Dam Plan'

You'd have thought the earth moved exactly two years ago with all the ballyhoo at the state Capitol when Gov. Hickenlooper unveiled the final Colorado Water Plan. I stood in the west foyer of the Capitol as every TV camera in the city pointed at Hickenlooper and his then Colorado Water Conservation Board director, James Eklund. Bold promises were made that the plan was going to save our rivers, farms, cities and the whole state from the coming catastrophe of population growth.

I was very involved in the Colorado Water Plan process, and at the time I issued a big caution in the form of a newspaper column printed in seven outlets across the state. I warned that the plan was too heavily focused on draining and damming rivers rather than protecting and restoring them.

Now, two years out from that unveiling, I take no solace in being right. The Colorado Water Plan has become the "Colorado Dam Plan."

If you look at the sheer amount of money spent so far or spending supported, the state's endorsements and loans for dams have out-sized water conservation and river restoration by a margin of at least 50 to 1. Before the ink was dry, Hickenlooper used to plan to endorse the \$350 million "Moffat Collection System Project," a massive enlargement of Denver Water's "Gross Dam" in Boulder County. In fact, it would build the tallest dam in the history of Colorado and fill it by draining another 4.5 billion gallons of water every year out of the already severely degraded Upper Colorado River in Grand County.

Next, Hickenlooper used the plan to endorse the \$380 million "Windy Gap Firming Project" which would take another 9 billion gallons of water every year out of the same Upper Colorado River, reducing its flow to a tiny fraction of its natural beauty. To add insult to injury, the CWCB (all appointed by Hickenlooper) then ran a bill through the Legislature to loan that project \$90 million to give it financial legs, because it couldn't stand on its own two feet.

And there's more. The so-called "Basin Roundtables," which are made up of self-appointed "stakeholders" from around the state, have used the plan to get funding from the CWCB for more planning and scheming about dams in northern Colorado on the Cache la Poudre River, in the southwest corner of the state on the San Juan River and in the northwest corner of the state on the White River.

At the same time most of that money and planning has flowed toward dams, the alternatives to dams and river protection have gotten extreme short shrift, just as I predicted two years ago. Despite all the rhetoric, a pittance of money has been allocated to water conservation, water recycling and reuse, and the highly touted "alternative transfer mechanisms" to share water with farmers. On that last note, the CWCB has promoted a few small "pilot" ATMs, including one larger one in Weld County which wasn't to increase water supply for growing cities — it was created to share water between farmers and frackers. Implementation of the plan also has allocated a tiny amount of money for "Stream Management Plans," but such little money has yielded a similar result.

In Fort Collins along the Cache la Poudre River, we just found out that Hickenlooper endorsed a "Fish and Wildlife Mitigation Plan" for a massive proposed \$850 million dam project called the "Northern Integrated Supply Project." Despite complete scientific opposition from actual wildlife scientists, the mitigation plan unanimously sailed through the Colorado Parks and Wildlife Commission and the CWCB, both appointed by Hickenlooper.

When the Colorado Water Plan was proposed four years ago, it was perceived by many educated onlookers as an effort by the Front Range growth machine to push through policy and funding to further dam and drain rivers to fuel and subsidize growth. Two years down the road, that perception has become reality. The original estimate of the cost of building all of the projects proposed in the plan was \$20 billion; that figure now has ballooned to \$40 billion.

I'm no longer skeptical about the Colorado Water Plan; I'm now working to stop it. Wherever you are in the state, if you hear someone touting the Colorado Water Plan, don't take the bait, again.

How to Disable a Nation: Authorities Lie and Citizens Deny

I have been operating as Renegade Research investigating the effects on physical and mental health by toxic metals that we are exposed to as a consequence of a long criminal history of mining in western states. After my 1995 retirement from the management of the Gates/Denver corporate Materials Analysis Laboratories, I decided to see if Colorado's environmental toxins were causing the severe health and behavior problems afflicting western states. I try to communicate some of the principal hazards to which children are exposed by neurotoxic air, water, soil and food. However, people deny an obvious truth if it makes them feel very uncomfortable as would fear, hatred of the poor, complicity in the ruthless social Darwinism poisoning our youth, historically driven by plutocrats, politicians, thugs, the American Medical Association & American Psychiatric Association.

In the case of lead, many states, including Colorado, are not testing children under Medicaid for blood lead twice by age of two, as required by federal law. Lead causes stupidity, bullying, ADD, alcohol and THC dependencies, schizophrenia and criminal behavior, often sexual and chronic illness including Diabetes and Osteoporosis, especially if Vitamin C and calcium are lacking in the diet. As counties do not test or ensure proper nutrition of poor children, this is the major reason they often fail. Molybdenum is the cause of Alzheimer's, cancers and many other diseases, as researched by the University of Colorado in the early 1970's termed the Molybdenum Project. The EPA covered up the findings as they showed that in addition to the direct effects on people, animals and sugar beets were being watered and fed by the South Platte River, which was collecting large amounts of tailings from the mines and mills upstream. The husband of one of my associates was the Director of Research at the Great Western Sugar Beet Co. Laszlo Toth had been a Yugoslavian sugar chemist and had some contacts at their sugar beet companies. Under the direction of the CIA, he set up a trip there to get surreptitious pictures of how they were operating their mills to remove molybdenum. He was exposed and convicted of being a CIA spy. He served a year and a half in their prisons until the US and the Yugoslavian government, run at that time by Marshall Tito, arranged his release. George H. W. Bush was then Secretary of State in President Ford's administration. Laszlo's book, "Stars Too Far" ISBN 088033-476-2, was not published until exactly 25 years later, per CIA policy for current agents. A recent headline – "Alzheimer's is the defining disease of the Boomer Generation". Medical studies found by Google show links between Alzheimer's, molybdenum and sugar.

On 9/26/2010, the Boulder Camera published a front page article on hate felonies and an editorial, "Sharing a Necessary Spotlight on Suicide". It is my assertion that both are caused by manganese (Manganism) exacerbated by lack of Vitamin C and organic iron in the diet. It is generated in runoff from the Rocky Mountains, in corroding iron drinking water pipes and pipelines, in aerosols from welding operations and coal smoke. Manganese Madness was very common among miners leading to their hate driven violence and strong dependence on alcohol and opiates for pain. Manganism today is seen as extreme, violent antisocial behavior, often domestic violence. An example was the man who welded iron panels to his bulldozer and attacked city buildings in the town of Granby until killing himself. He owned a muffler shop in Granby. Mass killings such as Columbine, Virginia Tech and NIU were well planned except for the getaway. The killers, enraged by the bullying of lead, seek death, taking those they hate with them in a public spectacle of destruction.

Manganese is unregulated for drinking water and therefore is not tested for. Its chemistry makes it very difficult to remove, generally requiring reverse osmosis filtration. Note in the editorial that the states with the top 10 highest suicide rates are Rocky Mountain States, from Arizona to Alaska, especially above 6500 feet above sea level. Above this elevation, the demographics are generally low income and protective nutrition may suffer as well as access to therapy. It is my hypothesis that the behavior of the Taliban is due to ingesting the runoff from the Hindu Kush. Afghanistan has significant mineral deposits, including copper that the Chinese outbid us for. Taliban drinking and cooking water, their food and their opium contain heavy metals, including manganese, causing their hate and suicidal behavior. The metals stay with the opium sap.

Airborne mercury from wildfire, natural gas and coal fired power plants is eventually washed into watersheds by rain and snow. Mercury is the cause of Chronic Wasting Disease in deer and elk, Multiple Sclerosis and Autistic Spectrum Disorder in humans. It compromises resistance to acute disease, such as flu, measles, HIV and Ebola, causes meth and heroin use, and is a potent endocrine disruptor. Mercury can lower birth weight, setting the newborn up for obesity, cancers and rapid aging.

Start/speed up the natural elimination of these metals with at least 5000 units of Vitamin D3 daily, along with sweating in the sun, preferably with exercise and RO water, year-round. For the sun-averse, go with far-infrared exposure, at the temperature of the human body.
