7 **for an ordinance amending Chapter 18 of the Revised Municipal Code to establish the 2018**  
8 **and 2019 salary and fringe benefits of the Sheriff, Deputy Sheriff Division Chiefs and**  
9 **Deputy Sheriff Majors.**

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 Section 1. That effective January 1, 2018, Chapter 18, Article IV, Section 18-101 of the  
14 Revised Municipal Code is hereby amended to read as follows:

16 Sec. 18-101. Deputy sheriff major, deputy sheriff division chief, and sheriff pay plans.

36 Deputy sheriff division chief promoted or appointed before January 31, 2016:
