Bump stocks enable a shooter to discharge 400-800 rounds per minute. One distributor, Slide Fire Solutions, advertised that their device enabled a shooter to unleash 100 rounds in 7 seconds. By contrast, the rate of fire for traditional semiautomatic weapons is primarily governed by the ability of the shooter to pull the trigger. Average shooters can usually fire 45-60 rounds per minute while maintaining some degree of accuracy. There is no reason that these devices need to be available for anyone. They allow for so much more killing to be done. I urge Denver City Council to do the right thing and pass the proposed bump stock ban (17-1400).
