The venues in question are in Council District 9 (Denver Coliseum and Red Rocks Amphitheatre). The contract amendment continues a commission program to incentivize Promoter to promote and book live concerts and events at the Denver Arts & Venues facilities. The purpose of this commission program is to increase revenues to the City in the form of ticket sales and concessions.
