#### **OPPORTUNITY**



- DEN conducted a Request for Expressions of Interest looking for:
  - An airport passenger lounge service operator to provide design, construction, operation, maintenance, and management of full-service passenger lounge at the Denver International Airport (DEN)
- RFI had a requirement to submit a proposal for an A Concourse Lounge
- RFI procurement structure allowed proposer to include a proposal for a C
   Concourse Lounge, if proposer felt the market existed
  - A proposal for a C Concourse Lounge was not a requirement and did not factor into the scoring

## SOLICITATION PROCESS



- Request for Expressions of Interest released September 1, 2017
- Question and Answer Session held on September 14, 2017
- One addenda issued on September 15, 2017
- Expressions of Interest were received October 13, 2017




- Term 10 years
- 11,751 square feet
- Minimum Capital Investment of \$10,846,542
- Proposed Privilege Fee (greater of)
  - Minimum annual percentage fee (MAPF) \$1,055,551
  - Percentage fee 13% initially, plus 1% increase every 2 years of the Term
- First year projected gross receipts \$9,550,000
- First year projected revenue to DEN \$1,055,551
- Capital investment \$10,846,542 (\$923 per sq.ft.)

# RECOMMENDED C CONCOURSE OPERATOR DEN

- American Express Travel Related Services Company, Inc.
- Experience
  - Operate eight Centurion Lounges in the US, one in Hong Kong and eleven other lounges worldwide
  - Exclusive to certain AMEX card holders, but will allow limited day passes.
  - Three Centurion Lounges in top ten of SkyTrax World's Best Independent Lounges for 2016 and 2017
  - Curate food and mixologist menus by partnering with local chefs
- ACDBE partners (15% goal)



#### THE CENTURION LOUNGE



- Term 10 years
- 14,650 square feet
- Minimum Capital Investment of \$14,034,700
- Proposed Privilege Fee (combination of)
  - Minimum annual percentage fee (MAPF) \$2,000,000, increasing annually
  - Percentage fee 25% of gross receipts
- First year projected gross receipts \$153,076
- First year projected revenue to DEN \$2,038,269
- Capital investment \$14,034,700 (\$958 per sq.ft.)
- ACDBE goal of 15%
