#### Goals

- Support a significant cultural institution and key resident company at the Arts Complex
  - Favorable rent at Boettcher and 1245 Champa that is adjusted for aging facilities
  - Upward trajectory of artistic programming and financial outlook, especially new endowment fund
  - Concerted efforts for outreach and engagement in community
- Provide assurance that the Symphony has a "home" at the Arts Complex
- Ensure that a public cultural asset is well-utilized and throwing-off ancillary revenue for the City (FDA tax, parking revenue, etc.)
- Invest in capital improvements and equipment to improve the patron and performer experience in BCH

Rent & Fees	Symphony: 5% of ticket sales and flat rate for rehearsals = \$286,000 (2016/2017)	<u>Symphony:</u> \$15,000/month = \$180,000/yr
Building Maintenance & Equipment	A&V: Average \$250,000/yr. (since 2010)	A&V Commitment: \$300,000 for capital improvements \$500,000 for capital equipment

Term	October 25, 2013 – July 3, 2017	January 1, 2018 – June 30, 2021 (co-terminus with BCH agreement)
Space	4 <sup>th</sup> floor	4th floor (currently occupied by Symphony) and option for ~1,000 sqft of 3rd floor
Rent	\$60,000/year plus utilities & expenses	\$1/year plus utilities & expenses

- City continues to receive FDA tax and ancillary revenue including parking, F&B, etc.
