Performance contract with the Colorado Coalition for the Homeless to expand the existing Social Impact Bond (SIB) program by an additional 75 individuals. The program provides housing and supportive services to chronically homeless individuals who have been identified as high cost users of government funded services. In contrast to the original SIB program, this contract is directly with the provider and does not utilize outside investment. Instead, it is a performance contract in which a portion of payment is based upon the performance of the program to maintain housing stability and to reduce among participants.

Provider will use a modified Assertive Community Treatment (ACT) team model of community-based clinical services, integrated with a flexible array of housing options delivered through an evidence-based Housing First approach to provide housing and supportive services for the costliest members of the “Super Utilizers” population.
