Aurora activist, lawmaker Nadine Caldwell honored May 9 with historic preservation distinction

AURORA | Longtime community activist Nadine Caldwell, former city council member and dedicated supporter of historic preservation in Aurora, will be honored May 9 with the Aurora Historic Preservation Commission's 2015 Elizabeth Johnson Award for Historic Preservation.

Because of inclement weather, a DeLany Farm ceremony has been moved to an event slated for 12:30 p.m. May 9 at the Aurora History Museum, 15051 E. Alameda Parkway, adjacent to city hall.

Caldwell grew up in Denver, and graduated from West High School. She represented Ward I on the Aurora City Council from 1989 to 2005.

Her passion has long been the redevelopment of Original Aurora, according to historic preservation activists. Caldwell served on the boards of three of the largest redevelopment projects in Colorado, all of which surrounded Ward I: the Lowry Redevelopment Authority, the Stapleton Development Corporation and the Fitzsimons Redevelopment

Authority.

Caldwell, a longtime board member for the Aurora Historical Society board, has dedicated thousands of hours to the preservation of Centennial House and its gardens. She also is founder of the Northwest Aurora Neighborhood Organization (NANO)—Aurora's first neighborhood organization—where she served as president for 13 years and still serves on the board.

She also has served as Aurora Economic Development Corporation board member; Sand Creek Regional Greenway founder and board member; Original Aurora Advisory Board member; Front Range Airport commissioner; Asian/Pacific Community Partnership steering committee member; E-470 Authority board member; Downtown Aurora Visual Arts founder and board member; Lowry Citizen's Advisory Committee member; and Stapleton Development Corporation and Metro Wastewater Board member.

Caldwell has been recognized with the following awards: 2001 Aurora Chamber of Commerce Woman of the Year; Christian Corp. About the Elizabeth Johnson Award for Historic Preservation

The Elizabeth Johnson Award honors community members who individually or with a group contribute to the historic preservation movement in Aurora. The first recipient was Mary Elizabeth Johnson, who worked tirelessly to preserve Centennial House, Aurora's 1890 historic house and one of the first homes built in Fletcher (later renamed Aurora).



Mr. Teegarden also worked as an attorney at Patton Boggs, LLP, concentrating on environment/natural resources, healthcare, alternative dispute resolution, and regulatory matters. From 1983 through 1990, he worked as Government Relations staff to the Denver Chamber of Commerce, participating in elections and other approvals for Denver International Airport, site selection for Denver Convention Center, Coors Field, and other civic projects.

He also previously worked in Washington, D.C., as staff to the U.S. House of Representatives Committees on the Budget and on Energy and Commerce.

Mr. Teegarden has served on a variety of volunteer boards and commissions in Colorado, including the State Board of Land Commissioners, the health and environment transition committees for Denver Mayor Hickenlooper and Colorado Governor Bill Ritter, and the Sand Creek Greenway, among others,

Legislative Director, Senate Majority Office. I am responsible for analyzing and monitoring the status of pending legislation and administrative policies and regulations for their impact on the State. I report to the Chief of Staff of the Senate Democrats. With the direction of the Chief of Staff, and in concert with the Press Secretary, the Policy Director, and legislative leadership, I coordinate the media and policy operations from the Senate Democratic Caucus. Allegra "Happy" Haynes

Allegra "Happy" Haynes (born March 4, 1953) is a Denver politician and consultant who formerly served on the Denver City Council and was an aide to two mayors.

Early life, education, and career

"Happy" Haynes was born in Denver, Colorado and graduated from Denver's East High School in 1971. Haynes received a B.A. in political science at Barnard College in 1975 and a M.A. in public affairs at the University of Colorado Denver in 2002. In addition, Haynes is a graduate of Leadership Denver, the Denver Community Leadership Forum, the Rocky Mountain Program and the State and Local Program at Harvard's Kennedy School of Government.

City of Denver

Haynes's 26-year-long connection to the City of Denver began in 1979, with her work as an aide to former Councilman Bill Roberts. From 1983 to 1990, Haynes was an administrative aide to Denver's first Latino Mayor, Federico Peña.

She won election to Denver City Council in 1990, becoming the first African American woman to serve on that panel. [1][2] Happy Haynes served three terms and was Council President from 1998 to 2000. During her time as a Council member, Haynes fostered city policies that focused on families, children, and educational reform. [3] From 2003 until 2005, Haynes served as Denver Mayor John Hickenlooper's liaison to the City Council and was involved with the development of Denver International Airport. [4]

Denver Public Schools

In October 2005, Haynes joined Denver Public Schools as the Assistant to the Superintendent for Community Partnerships and worked alongside then Superintendent Michael Bennet to direct and "oversee the district's initiatives on parent involvement, school partnerships, school culture and climate, mentoring and volunteer programs. [5] In 2008, Governor Bill Ritter appointed Haynes to the Colorado Commission on Higher Education. Also working closely with the National Association for Urban Debate, Happy Haynes was personally involved in the efforts to increase student participation in debate. In 2009, Haynes recruited six high schools and awarded the students at the first tournament. [6] Haynes became the Chief Community Engagement Officer for Denver Public Schools in 2009, assigned to "strengthen relationships with community organizations and business partners." [7]

In 2011, she left the school district and accepted a position with CRL Associates, a political and public administration consultancy. [6] When she resigned her school district position, she said she would be a candidate for the city school board. [9]
