# FIRST AMENDMENT TO AGREEMENT FOR SERVICES COMPSYCH EMPLOYEE ASSISTANCE PROGRAMS, INC.

This FIRST AMENDMENT to the agreement with COMPSYCH EMPLOYEE ASSISTANCE PROGRAMS, INC., ("**First Amendment**") is entered into by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "**City**") and COMPSYCH EMPLOYEE ASSISTANCE PROGRAMS, INC., 455 N. Cityfront Plaza Dr., 13<sup>th</sup> Floor, Chicago, IL 60611 (the "**Consultant**")(collectively, the "**Parties**").

### **RECITALS**

**WHEREAS,** the Parties entered into that certain services Agreement dated September 25, 2013 ("**Agreement**"), and;

**WHEREAS**, the Parties desire to amend the Agreement to both: extend the term of the Agreement, and; increase the maximum compensation to the Consultant as shown herein.

#### **AGREEMENT**

**NOW, THEREFORE**, in consideration of the premises, the mutual agreements herein contained, and subject to the terms and conditions hereinafter stated, the Parties agree as follows:

- 1. Paragraph 3 of the Agreement (entitled "**Term**") is hereby amended to read as follows:
  - "3. <u>TERM</u>: The Agreement will commence on October 1, 2013 and will expire at 11:59 p.m. on December 31, 2016 (the "Term")."
- 2. The first sentence of Paragraph 4(d)(1) of the Agreement (entitled "Maximum Contract Amount") is hereby amended to read as follows:

### **"4. COMPENSATION AND PAYMENT:**

- d. Maximum Contract Amount:
- (1) Notwithstanding any other provision of this Agreement, the City's maximum payment obligation shall not exceed SEVEN HUNDRED THOUSAND and NO/100 DOLLARS (\$700,000.00) (the "Maximum Contract Amount")."
- **3.** This First Amendment may be executed in counterparts, each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and the same instrument.
- **4.** Except as herein amended, the Agreement is affirmed and ratified in each and every particular.
